2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.

4. Intake capacity will be 100 as per NCTE norms considering the present situation 100 students should be admitted for the academic session 2025-27.
5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE, UGC and State govt. norms. Payment of salary must be through proper procedure as directed by the Govt. / NCTE.

:

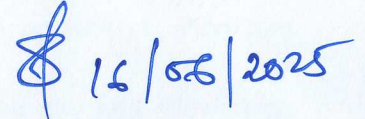
